Dear Health System Partners,

This bulletin provides important guidance regarding the process for requesting non-emergency medical transportation services, including updates to the non-emergent ambulance post authorization process, effective January 1, 2026.

## **I. Non-Emergency Ambulance Transportation**

### **Ambulance Post Authorization Process**

Effective January 1, 2026, non-emergent ambulance transport will be eligible for post authorization when the transport is non-emergent.

- Post authorization applies only to transport originating from a medical facility/hospital
- Transportation originating from a private residence or other non-hospital locations must be coordinated through Medical Transportation Management (MTM)
- This applies for AmeriHealth Caritas Pennsylvania (PA) Community HealthChoices (CHC) and AmeriHealth Caritas VIP Care in Pennsylvania plans.

### **Documentation Requirements**

The referring medical facility is responsible for ensuring all required documentation is completed and maintained including:

- A clinical assessment by the referring physician confirming the medical necessity of ambulance transport
- Completion of a physician certification statement or PCS validating the medical requirement for ambulance services

### **Role of the Medical Facility/Hospital**

Medical facilities are responsible for the following steps when arranging non-emergent ambulance transportation:

- Determine eligibility – verify the patient's insurance carrier to confirm whether MTM is the appropriate transportation manager
- Scheduling transportation – schedule non emergent ambulance transportation directly with an MTM approved and contracted ambulance provider

### **In the event of Medical Facility/Hospital Contracted Provider Unavailability**

If the medical facility or hospital needs assistance with scheduling non-emergency ambulance transportation or is unable to secure an available ambulance provider, please contact MTM for assistance in coordinating and scheduling the required transportation services.


